The term endowment includes a stipulation that it be held for five years to earn income and then will be released to unrestricted net assets for general operating expenses should the board of directors deem it necessary. As of December 31, 2014, it is the intention of the board of directors to preserve the donor endowment gifts and earnings. Net assets associated with endowment funds, including funds designated by the board of trustees to function as endowments, are classified and reported based on the existence or absence of donor-imposed restrictions.

Management believes it is no longer subject to income tax examinations for years prior to 2011.
